2. The total amount combines successive visas and multiple entry visas together since April, 2007. However, the amount of successive visas and multiple entry visas in April, 2007 is cumulative, which results in a substantial increase in the amount of mainlanders visited Taiwan in that month.

3. Growth rate is the year-on-year growth rate.

4. To avoid the misunderstanding of statistics due to different announced items. These data from Jan. 2010 referred to "The application statistics of people from Mainland China to enter Taiwan" announced by National Immigration Agency.
