Since January 2014, adjusting statistical methods for coordinate Ministry of the Interior revised relevant permission, which made the amount of the visitors to Taiwan for economic and trade related activities is increase. Besides, economic and trade related activities mean the professional and business activities.

5. People from Mainland China to enter Taiwan statistics, in August 2014 with National Immigration Agency amended in January and February statistics, related data had slight changed.
