Note: 1. Mainland China tourists have been allowed to visit Taiwan since January 2002.

2. The first half year of 2003, because of the SARS infectious, the government took strict control policy on the immigrant from mainland china. Thus, the hush total of traveling from mainland decreased drastically.

3. The total amount combines successive visas and multiple entry visas together since April, 2007. However, the amount of successive visas and multiple entry visas in April, 2007 is cumulative, which results in a substantial increase in the amount of mainlanders visited Taiwan in that month.

4. Growth rate is the year-on-year growth rate.

5. To avoid the misunderstanding of statistics due to different announced items. These data from Jan. 2010 referred to "The application statistics of people from Mainland China to enter Taiwan" announced by National Immigration Agency.
