3.\* before 2001 the estimation method of Mainland Affairs Council (MAC)as: (B1-B2)+C.

But since 2002 MAC and Bureau of Foreign Trade(BOFT) decided to change the formula and switch to A+(B1-B2)\*80%+C-r\*A.

"r" presents the average ratio of the import from Taiwan in Guangdong to all in China according to China Customs Statistics.

Now the "r" is 33% from 1999 to 2002.
