4. The trade statistics has been adapted to general trade system since CY 2016. In accordance with the applying of general trade system, the principal commodity classification was revised and historical data were revised to CY 2001.

5. From Jan. 2006, the Compilation of Customs Trade Statistics adopts the United Nations' International Merchandise Trade Statistics (IMTS) Compilers Manual, 2004. Under IMTS Criteria, the data of re-exports and re-imports of each classification are included in their relevant total exports/imports, respectively. The historical data in 2004 & 2005 have been revised on this table.
