## Applying for a visa to Republic of China (Taiwan)

- 1. Applicants are required to come personally to our office.
- 2. Our office hour for visa application: 9:00 to 12:00 a.m., Monday to Friday (Except Macao Public Holidays)
- 3. Processing Time:
  - 3 working days for regular service and 1 working day for express service.

## 4. Requirements:

- (1) Completed & signed "General Visa Application" form: please access the website: <a href="https://visawebapp.boca.gov.tw/">https://visawebapp.boca.gov.tw/</a>, select "Asia-Taipei Economic and Cultural Office, Macao" as the place where you will be applying for your visa, fill it, submit and print it out.
- (2) Passport (original & photocopy): Valid for 6 months with blank pages.
- (3) Two passport-size photos in color with white background, taken within 6 months.
- (4) Travel itinerary, round-trip ticket, hotel reservation, evidence of funds and other supporting documents according to the purpose of visit.
- (5) Additional documents and interview may be required.
